
Chairman Schaaf called the Special Meeting to order at 9:30 a.m.

The alternatives included additional information related to the conditioning and fire rating of the shell spaces. **Commissioner Maez moved to approve Change Order Number 001 with Nunn Construction, Inc. related to the construction of the Archuleta County Combined Courts Facility in an amount not to exceed \$405,470.63 and to authorize the County Administrator to execute the documents as presented. Commissioner Brown seconded the motion and it carried unanimously.**
