### A. Consideration And Approval Of Animal Shelter Management And Services Agreement With Humane Society Of Pagosa Springs

This Agreement renews the service agreement to provide shelter for impounded, strayed and surrendered animals in the County. The Humane Society has requested an increase in fees from \$50,000 to \$62,500 per year plus increasing the impound fee from \$35 to \$40 and the housing fee from \$15 to \$20 per day.
