**ARCHULETA COUNTY PROCEEDINGS
BOARD OF COUNTY COMMISSIONERS**

The Board of County Commissioners held a Special Meeting on September 14, 2021 with County Commissioners Alvin Schaaf, Ronnie Maez and Warren Brown, County Administrator Scott Wall, County Attorney Todd Weaver and County Clerk and Recorder Kristy Archuleta present.


Chairman Schaaf called the Special Meeting to order at 10:00 a.m.

New Business

A. Approval of Construction of Constructing Walkway Between Justice Facility and Detention Center

Scott Wall, County Administrator, stated the Sheriff's Office had requested adding a change order to the Nunn Construction contract to add a connecting walkway between the Detention Center and the Justice Facility which was currently being built. Nunn Construction had provided four options for the walkway. The walkway would help alleviate any possible COVID contamination between inmates and the general public. **Commissioner Maez moved to approve funding from the American Rescue Plan Act funds for Nunn Construction's Option #2 for the construction of a connecting walkway between the Detention Center and the Justice Facility in an amount not to exceed \$280,806.01 as presented and to direct County Administrator to negotiate and execute the necessary change order. Commissioner Brown seconded the motion and it carried unanimously.**

With there being no further business before the Board, the meeting was adjourned at 10:03 a.m.

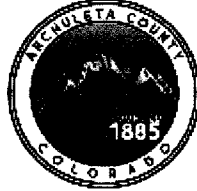
